What's Going On in the Tennessee State Legislature...

- 33 Senators and 99 Representatives
- Function: to enact, amend, and repeal the laws of Tennessee
- 112<sup>th</sup> General Assembly, 2<sup>nd</sup> year, adjourned April 28, 2022
- Big initiatives: revamping funding for K-12 public schools, record high in Rainy Day fund, and over \$280 mil in tax and financial relief


# New Legislation Highlights



## Budget

#### FY 2023 Recommended Budget Totals \$52.5 Billion, an Increase of 2.5%

#### Budget: Education

- \$6.5 billion (\$1 billion in new funding)
- Largest increase in K-12 funding in TN history
- Tennessee Investment in Student Achievement (TISA) Act
- Increase teacher salaries
- Reduce TCAT waitlists & improve infrastructure
- Increase HOPE scholarship awards
- No tuition increase at state schools this year (Go Vols!)

#### Law enforcement training


## 100 additional state troopers

20 additional TBI agents (human trafficking, cyber security, narcotics, forensics)

Educational technology in local jails & evidence-based programming

Crime prevention Truth in Sentencing legislation

Grants for volunteer fire departments and rescue squads



#### Budget: Health & Welfare

- \$5.5 million mental health treatment centers
- \$3 million 3 year pilot program for respite care for Alzheimer's and dementia caregivers
- \$9.7 million salary increase for DCS caseworkers
- \$1 million suicide prevention
- Foster Care/Adoption childcare vouchers
- Postpartum coverage extended from 60 days to 12 months for TennCare enrollees

## Budget: Tax Relief

- $\circ~\$281\,million\,in\,tax\,and\,financial\,savings$
- \$80 million grocery sales tax holiday August 2022
- \$121.6 million eliminate state license plate registration fee for Tennessee residents
- \$68 million broadband supplies
- \$2.8 million sales tax on agricultural machinery
- \$9 million physician professional privilege tax
- \$360,000 tax on gold, bullion, silver




## EDUCATION

#### Education: K-12



- Revamping the public school funding formula: TISA
- Library Transparency Implementing student, parental and employee feedback re: age appropriateness of materials in school libraries (Pub. Ch. 744)
- **School Computers** Increasing safeguards against obscene materials (Pub. Ch. 1002)
- Human trafficking Expanding training for detecting, intervening and preventing human trafficking and treatment of child victims (Pub. Ch. 1021, eff. July 1)
- **Sports** Student's gender for purposes of school sports is determined at time of birth (Pub. Ch. 909, eff. July 1)
- Addressing school staffing shortage retirees who have been retired for 60+ days can accept reemployment as K-12 teacher, sub, or bus driver without loss or suspension of benefits under certain conditions (Pub. Ch. 821)




#### Education: Higher Ed

- Expanding internships by lowering minimum age for work-based learning students to 16 (applicable beginning 2022-2023 school year; SB 0520)
- Women's NCAA sports prohibits biological male students from competing in women's college sports and intramurals (SB 2153)
- Tuition for veterans permits boards of state universities to offer in-state tuition to active-duty military and veterans regardless of TN residency (SB 2486)





#### Healthcare

- COVID laws visitation at end-of-life during public health emergencies for nursing home and assisted living facility residents (Pub. Ch. 1123); medical and religious exemptions for COVID-19 vaccine mandates, \$10,000 fine for noncompliance (Pub. Ch. 644)
- Combatting opioid crisis expanding access to opioid antagonists (Pub. Ch. 1061); adds tianeptine to controlled substance list (Pub. Ch. 1135)
- Human Life Protection Act supersedes Heartbeat Bill (6 week ban), prohibits all abortions in the state except for medical emergencies; Class C felony for a person to perform or attempt to perform an abortion; prohibits criminal prosecution of a woman upon whom an abortion is performed or attempted (eff. August 25, 2022, 30 days after overturn of *Roe v. Wade*)
- Access to wheelchairs prohibits health insurer from considering where Complex Rehabilitation Technology may be used when making determination re: medical necessity, allows wheelchair users to obtain CRT through insurance even when taking chair to church or grocery store (Pub. Ch. 973)





#### Commerce

- Work requirements reinstated for SNAP benefits – returns to pre-pandemic, ablebodied individuals between 18 and 49 must work, train or volunteer at least 20 hours per week (Pub. Ch. 972)
- Blockchain allows creation of Decentralized Autonomous Organizations (DAOs) and permits them to engage in business in the state; positions the state to receive DAOs and become leader in blockchain technologies (Pub. Ch. 852)
- COVID liability protection protects businesses, schools, churches and other entities from COVID-19-related loss or injury claims until July 1, 2023 (Pub. Ch. 1117)
- Pesky subscription services requires businesses to provide straightforward cancellation process for subscription services (Pub. Ch. 803, eff. Jan. 1, 2023)


